2021 Water Quality/Consumers Confidence Report for CRYSTAL FALLS TOWNSHIP – LIND & TOWNLINE

This report covers the drinking water quality for the Lind and Townline systems operated by Crystal Falls Township, for the calendar year 2021.

Lind water system has three groundwater wells. Two of the wells are located two miles west of highway 141 on the Lind Road; the second well is located on Kuivila Road one-half mile north of the main well. The Townline water system has two wells housed in one building and are located on Townline Road one-quarter mile east of Highway 141.

The State performed an assessment of our Lind source water in 2003 to determine the susceptibility or the relative potential of contamination.

- Sources of drinking water: The sources of drinking water (both tap water and bottled water) include rivers, lakes, streams, ponds, reservoirs, springs, and wells. Our water comes from wells. As water travels over the surface of the land or through the ground, it dissolves naturally-occurring minerals and, in some cases, radioactive material, and can pick up substances resulting from the presence of animals or from human activity.

- Contaminants that may be present in source water include:
 - T **Microbial contaminants**, such as viruses and bacteria, which may come from sewage treatment plants, septic systems, agricultural livestock operations and wildlife.
 - T Inorganic contaminants, such as salts and metals, which can be naturally occurring or result from urban stormwater runoff, industrial or domestic wastewater discharges, oil and gas production, mining or farming.
 - T Pesticides and herbicides, which may come from a variety of sources such as agriculture and residential uses.
 - T Radioactive contaminants, which are naturally occurring or be the result of oil and gas production and mining activities.
 - T Organic chemical contaminants, including synthetic and volatile organic chemicals, which are by-products of industrial processes and petroleum production, and can also come from gas stations, urban stormwater runoff, and septic systems.

STATEMENT ABOUT LEAD: Infants and children who drink water containing lead in excess of the AL could experience delays in their physical or mental development. Children could show slight deficits in attention span and learning abilities. Adults who drink this water over many years could develop kidney problems or high blood pressure.

If present, elevated levels of lead can cause serious health problems, especially for pregnant women and young children. Lead in drinking water is primarily from materials and components associated with service lines and home plumbing. Crystal Falls Township is responsible for providing high quality drinking water but cannot control the variety of materials used in plumbing components. When your water has been sitting for several hours, you can minimize the potential for lead exposure by flushing your tap for 30 seconds to 2 minutes before using water for drinking or cooking. If you are concerned about lead in your water, you may wish to have your water tested. IMPORTANT INFORMATION ABOUT YOUR DRINKING WATER

Monitoring Requirements Not Met for Crystal Falls Township - Townline

We are required to monitor our drinking water for specific contaminants on a regular basis. Results of regular monitoring are an indicator of whether or not your drinking water meets health standards. During December 2021, we did not complete all monitoring or testing for total coliform bacteria, and therefore cannot be sure of the quality of your drinking water during that time.

What happened? What is being done?

We took our required monthly routine bacteriological sample on December 10, 2021. We were notified that the sample was total coliform positive on December 14, 2021. Within 24 hours, we are required to collect at least one groundwater source sample from each groundwater source in use at the time the total coliform positive sample was collected. Samples were collected on December 14, 2021, however due to a severe windstorm power was lost at the lab and the samples were unable to be analyzed. We returned to compliance on December 17, 2021, when we collected the required ground water samples. All samples taken on December 17, 2021, were negative for total coliform bacteria. We are making efforts to ensure this does not happen again.

What should I do?

There is nothing you need to do at this time. This is not an emergency. You do not need to boil water or use an alternative source of water at this time. The results of the sample were negative for bacteria. Even though public health was not impacted, as our customers, you have a right to know what happened and what we did to correct the situation.
